## **2. Pakistan's Plant Breeders' Rights Act adopted by the National Assembly**

(by Laurent Gaberell, Public Eye) On September 5, 2016, the Pakistan National Assembly adopted a [Plant Breeders' Rights Act](#) "to encourage the development of new plant varieties and to protect the rights of breeders of

such varieties". The Act provides protection for new plant varieties while at the same time respecting the right of farmers to save, use, exchange and sell farm-saved seeds, a practice which is the backbone of agricultural system and the main channel through which farmers get access to seeds in Pakistan and most developing countries.

One of the new procedures for granting PVP in Brazil is the requirement of a declaration of access or non-access to national genetic heritage samples or associated traditional knowledge (access declaration) that might have occurred during the development of a new plant variety.
