# DRAFT PROGRAM FOR A "SEMINAR ON PROPAGATING AND HARVESTED MATERIAL IN THE CONTEXT OF THE UPOV CONVENTION", TO BE HELD IN GENEVA ON OCTOBER 24, 2016

1. The purpose of this document is to make proposals concerning the draft program for the "Seminar on Propagating and Harvested Material in the context of the UPOV Convention," to be held in Geneva on October 24, 2016.

2. The Administrative and Legal Committee (CAJ), at its seventy-second session, held in Geneva on October 26 and 27, 2015, "agreed to propose to the Council to organize a one-day seminar on propagating and harvested material to be held in conjunction with the UPOV sessions in October 2016. The seminar should include speakers to report on cases in which the notions of harvested material and/or propagating material have been considered, and speakers from relevant academic institutions and judicial authorities to provide perspectives on the subject. CAJ members and observers would be invited to propose speakers. The Office of the Union, Chair of the CAJ and President of the Council would prepare a draft program for consideration by the Consultative Committee and approval by the Council in March 2016" (see document CAJ/72/9 "Report on the Conclusions," paragraph 27).

3. On the basis above, the Council, at its forty-ninth ordinary session, held in Geneva on October 29, 2015, approved the organization of a "Seminar on propagating and harvested material in the context of the UPOV Convention", to be held in Geneva on October 24, 2016 (see document C/49/18 "Report on the Decisions," paragraphs 54 and 55).

4. In accordance with the request in paragraph 2 above, UPOV issued Circular E-16/005 on January 18, 2016, to designated persons of members and observers in the Council and the CAJ to propose speakers in writing by February 5, 2016, who would be able to:

"(a) report on cases in which the notions of harvested material and/or propagating material have been considered; or

(b) provide analysis on the notions of harvested material and/or propagating material based on real situations or cases."

5. On the basis of replies to Circular E-16/005, the Office of the Union, Chair of the CAJ and President of the Council have prepared a draft program for consideration by the Consultative Committee and approval by the Council in March 2016. The Draft program is reproduced in the Annex to this document.

6. It is proposed that invitations to the Seminar be sent to members and observers in UPOV bodies and that the Seminar be open to the public with advance registration, with the presentations and a video of the Seminar being made available on the UPOV website after a suitable broadcast delay. A publication of the

proceedings of the Seminar, containing the speakers' written contributions and a summary of discussions, would be made available on the UPOV website at a later date.

7. The Consultative Committee is invited to recommend to the Council:

(a) the approval of the draft program for the "Seminar on Propagating and Harvested Material in the context of the UPOV Convention," to be held in Geneva on October 24, 2016, as proposed in the Annex to this document;

(b) that invitations to the Seminar be sent to members and observers in UPOV bodies and that the Seminar be open to the public with advance registration, with the presentations and a video of the Seminar being made available on the UPOV website after a suitable broadcast delay; and

(c) a publication of the proceedings of the Seminar, containing the speakers' written contributions and a summary of discussions, would be made available on the UPOV website at a later date.
