1. By letter of August 10, 2018, Mr. Fernando dos Santos, Director General of the African Regional Intellectual Property Organization (ARIPO), requested the extension of observer status to the Administrative and Legal Committee (CAJ), the Technical Committee (TC) and the Technical Working Parties (TWPs). A copy of the letter is contained in the Annex to this document.

2. ARIPO already has observer status in the Council.

3. The "Rules Governing the Granting of Observer Status to States, Intergovernmental Organizations and International Non-Governmental Organizations in UPOV Bodies" (see document UPOV/INF/19/1, paragraph 3(c), available at <a href="http://www.upov.int/information\_documents/en/">http://www.upov.int/information\_documents/en/</a>) provide as follows:

"(c) Organizations which have been granted observer status to the Council may subsequently request, by means of a letter from the head of the organization, observer status to the CAJ, the TC and/or the TWPs, if this was not initially requested."

4. As provided in document UPOV/INF/19/1 (see paragraph 2 (c)(ii), (d)(ii) and (e)(ii), the Consultative Committee is responsible for deciding which intergovernmental organizations should be granted observer status to the CAJ, the TC and the TWPs.

5. The Consultative Committee is invited to consider the request of ARIPO for the extension of observer status to the CAJ, the TC and the TWPs.
